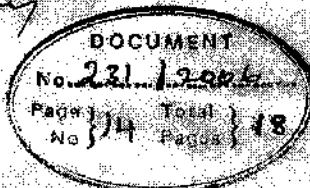
The normal tenure of the Board of Trustees shall be two years and they shall be eligible for re-election at the meeting of the Board of Trustees convened after completion of every two years. The Board of Trustees shall elect the chairman and Managing Trustee among them.

6. The Board of Trustees shall meet as many times as necessary to transact business but it shall be atleast once in three months. The presence of three members shall form the quorum.

7. The meeting of the Board of Trustees shall be convened by the chairman or managing Director with at least three days prior notice to all members of the Board of Trustees.

Any urgent decision of the Board of Trustees may be finalised by circulation of papers concerning the subject among all the members of the Board of Trustees.

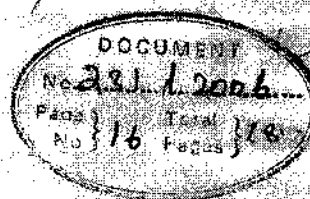

- e) to change from one form of investments into another approved investments as they deem fit and proper.
- f) to deal with, enter into agreements, sell, mortgage, charge, lease, hire, invest, transfer investments, open bank accounts and generally deal with Trust Fund or any part thereof as the Board of Trustees may consider necessary or desirable from time to time.
- g) to institute and conduct or defend any legal, civil, criminal, Revenue, Tribunal, Labour courts or other proceedings involving the trust and to engage counsel or attorneys and to give them such vakalats or power of attorney as may be necessary.
- h) to frame rules and bye-laws for the conduct of the business of the trust and of its transactions.
- i) an account shall be opened for the Trust in the name of the Trust with Nationalised or Scheduled Banks and the same shall be operated by the Managing Trustee or any of authorised trustees on E or S basis.
- j) the funds of the trust shall be invested only in accordance with the provisions of section 13(1)(d) read with the section 11(5) of the Income Tax act, 1961.
- k) all monies including the main corpus of the trust and of accumulating and receipts of this trust shall be held only in the name of this trust and not in any individual name/names of the trustees.
- l) the accounts of the trust shall be maintained properly and shall be closed on the 31<sup>st</sup> March of each year.
- m) the accounts of the trust shall be audited every year by a Chartered

- n) the net income arising out of the trust properties whether movable/immovable after meeting the necessary expenses shall be utilised only for the aforesaid purposes, in India alone.
- o) the trust shall not carry on any activity outside India.
- p) the trust shall not carry on activity with the intention to make a profit.
- q) The income of the trust shall be solely utilised towards the objects of the trust and no portion of the income or fund shall be utilised for payment to the trustees by way of profit, interest, dividend or any other head.
- r) the trustees shall be entitled to appoint such staff for administering the trust properties on such terms as they may decide and shall have the power to dismiss the persons so appointed.
- s) the Board of Trustees may appoint committees or sub-committees for such periods and on such terms as it deems fit and dissolve any of them.
- t) the chairman or managing trustee shall have power to issue receipts, sanction expenses, execute any documents, make any compromise, negotiate any business or service activity in favour of the Trust.
- u) the Board of trustees shall be entitled to frame, modify and amend the rules for the purpose of administering the trust in a more beneficial manner even though the trust is irrevocable. However the powers to effect amendments to the Memorandum of Association by the office bearers does not extent to altering the basis character / objects of the trust.
- v) in the event of trust being dissolved or wound up, the assets of the trust shall be transferred to any other trust of charitable nature.

10. Any amendment to the deed of trust shall be carried out only with the approval of the Commissioner of Income Tax having jurisdiction to the trust.

11. No immovable property is owned by this Trust Deed as on date. The asset of the trust is only Rs.7,000/- as on date.
